# **Payment Policy**

Our funeral home out of necessity operates on a cash basis. We rely upon the families we serve for prompt payment. We do not have sufficient financial resources to extend credit over an extended period of time, nor are we able to fulfill the function of a bank or other lending institution. Therefore payment is expected at the time of arrangements and due 24 hours prior to services rendered. We encourage an open and honest discussion regarding this matter with your arrangement advisor. We will attempt to assist you in every way possible.

# Basic Services of Funeral Director and Staff, including Overhead

Our services includes; conducting the arrangement conference; preparation and filing a death certificate and obtaining the permit for disposition; planning and coordination of funeral or memorial services details; care and sheltering of the decedent; coordination with the cemetery or crematory; clerical and administrative duties; composition and submission of obituary notices. Also included is a proportionate share of our cost of doing business. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**Embalming** \$1150

Embalming provides temporary preservation of the body through a chemical process. Embalming must be performed by a person licensed by the State of California. Except in certain special cases, embalming is not required by law. Embalming may be necessary however if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

The price of this service does not include our assistance in planning a funeral or memorial event or any aspect thereof; viewing or any other additional service.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative container we provide is cardboard.
